


Dear Friends of the Balkan Rivers,

Lots of things have happened at the Balkan Rivers since our last newsletter in October. Here are the highlights:

* Mavrovo: Case against Macedonia

The Standing Committee of the Bern Convention (= Convention on the Conservation of European Wildlife and Natural Habitats) is initiating proceedings against Macedonia due to the projected construction of hydropower plants in the Mavrovo National Park. A group of experts will investigate whether the projects violate the Convention. [More](#)

* Vjosa Tour: Municipalities and people want national park instead of dams

In mid-December, the first public discussions about the future of the Vjosa Valley took place in southern Albania. While the government envisage the construction of eight dams along the river, the mayors and people of the affected communities support the alternative idea of establishing a national park. *** Sava River: NGOs protest**

In an [open letter](#), 15 environmental NGOs protest against the intention of the International Sava River Basin Commission to adopt a management plan for the Sava River basin. This plan is based on misleading and false data; it is violating EU legislation and risking the future of the Sava – one of the most valuable river ecosystems in Europe. [More](#)

*** Hydropower projects planned in Una National Park in Bosnia**

Together with international investors, the Bihać municipality is lobbying to amend the federal spatial plan in order to allow building small hydropower plants in the [heart of the Una National Park](#). Proposals for 4 locations have already been put forward. These plans threaten to destroy the most beautiful spots in the park, such as a spectacular travertine laguna of numberless small islands and waterfalls. Local resistance exists; however, the issue is still rather unknown to the wider public.
