






She holds a PhD in Political Ecology and has carried out extensive research on the social impacts and politics associated with hydropower conflicts in the Eastern Himalayas, India.

### **Andrej Sovinc**

Andrej is an ornithologist and a protected areas/natural resource management consultant with a doctorate in protected area systems. He has vast experience in the planning, establishment, and management of protected areas, including Natura 2000 sites and has been active in international conservation since 1995. As the former European Vice-Chair of IUCN's World Commission on Protected Areas he has coordinated a network of over 700 experts since 2012.

### Andrijana Mićanovic

Andrijana is a biodiversity researcher specialising in herpetofauna and batrachofauna. As co-director of the Montenegrin Ecologists Society, she coordinates projects focused on endangered species and habitat conservation, especially in freshwater ecosystems. She is actively involved in mapping and establishing the Natura 2000 network and is one of the key initiators of the "Save Komarnica" initiative, dedicated to protecting the Komarnica Canyon.

### **Annette Spangenberg**

Annette is the Head of the Freshwater Programme and part of the Senior Management Team at EuroNatur Foundation. She has been with the organization since 2002 and has been involved in the campaign "Save the Blue Heart of Europe" since its inception in 2011/2012. As a mother of two girls (9 & 12) she is dedicated to preserving nature for future generations.

### Azra Berbić

Azra is a long-time environmental, human rights and peace building activist and a lawyer, she is a member of Foundation Atelier for Community Transformation - ACT.

### **Besar Likmeta**

Besar is the Country Editor for BIRN Albania since 2007and serves as the country correspondent for Balkan Insight. He has worked in journalism across print, television, and electronic media in the US and Albania since 2003. In 2009, he won the CEI/SEEMO Award for Investigative Journalism. Besar studied philosophy at the University of North Florida.

### **Bonnie Barclay**

Bonnie is a Communications Consultant at Rising Action Strategies and formerly served as Global Communications Manager for International Rivers, where she led strategic initiatives to amplify the voices of communities impacted by harmful river projects. With over 25 years of experience in environmental and social justice advocacy, Bonnie has worked with organisations like Greenpeace, MoveOn, and UCLA's Institute of the Environment. She holds dual Bachelor's degrees in Wildlife, Fish & Conservation Biology and Environmental Science, specialising in Policy and Watershed Management.

### Branka Knežević

Branka is a biologist, working in local self-government for over 15 years in the Secretariat for Spatial Planning and Sustainable Development, Capital City Podgorica, competent for environmental topics on a local level.

### Bruno D'Amicis

Bruno is a renowned nature photographer with a background in biological sciences. His award-winning work has been featured in global publications like National Geographic, GEO, & Smithsonian. In addition to his photography, Bruno has authored eight books, produced three documentaries, and led several conservation projects.

### **Chris Vettos**

Chris is working for REScoop.eu, the European Federation of Energy Cooperatives, and Electra Energy (Greece). Both organisations promote the active engagement of citizens in renewable energy production in Europe. He has worked on multiple research programs as an assistant, on topics like the EU Green Deal and degrowth.

### **Cornelia Wieser**

Conny has been involved in the Blue Heart campaign since 2013 and is responsible for public relations, partner coordination, event planning, etc. She was the lead organiser of the Balkan Rivers Days 2015 (Belgrade) and the European Rivers Summit 2018 (Sarajevo), helping to unite the movement for river protection across Europe.

### **Danijel Loncar**

Danijel is a communication expert with a knack for storytelling and connecting people to important causes. He leads teams in designing meaningful campaigns, focusing on nature conservation and community engagement, looking for ways to reconnect people and rivers through storytelling.

Elena is an Associate Professor with 13 years of experience, specialising in EU Policy and its implementation in Albania. At the Agriculture University of Tirana, she has contributed to numerous European Commission research projects, focusing on sustainability, climate change, and urban agriculture. Her work centres on economic behaviour and sustainable development, with several scientific publications exploring the Green Deal and institutional challenges.

### Ema Breščak

Ema is a marine biologist and an ecologist from Slovenia, currently working for REVIVO - Institute for ichthyological and ecological research. She also works with the River Collective as part of their organising team for this year's SRC Neretva 2024 in Ulog, BiH.

### Fanourios-Nikolaos Sakellarakis

Fanourios-Nikolaos is an ecologist specialising in biodiversity conservation, with a degree in Forestry and a Master's in Ecology. He worked at Prespa National Park in Greece researching vegetation dynamics and later joined the Society for the Protection of Prespa, creating one of Greece's most detailed floristic inventories. In 2022, he joined MedINA, where he currently is Conservation Coordinator, leading the Freshwater Ecosystems Pillar.

### Gjorgji Mitrevski

Gjorgji is Water Programme Coordinator at Eko-Svest. He leads public awareness campaigns by collaborating with artists, art collectives, cultural and educational organizations. Along with introducing citizen science and supporting protected area authorities in monitoring river conditions, he is engaged in establishing new protected areas, promoting proactive and long-term river conservation efforts.

### Hasan Hadžiablahović

Hasan is a young botanist, expert in mapping Natura 2000 habitats, and currently employed in the Municipality of Tuzi as a Senior Adviser for Ecology, Sustainable Development and Environment Protection.

### Iva Korbar

Iva founded the artistic platform Ljubav za Ričinu in autumn 2020 for recognition and protection of river Rječina, city of Rijeka. Playful, dynamic creation at many fields is her drive. Iva does site-specific performing arts in nature, writes acrobatic texts, creates poetic videos, does PR, guides people in mountains, islands etc.

### Irma Popović Dujmović

Irma is a Freshwater Program Director for Croatia at The Nature Conservancy. She has more than 20 years of experience working for the non-governmental sector in policy, advocacy, education, and promotion of river ecosystem conservation, public participation, and integrated river basin management.

### Iva Kljajević

Iva holds a master's degree in ecology from the University of Montenegro. She was awarded a Ceepus scholarship at the University of Natural Resources and Life Sciences in Vienna. As a researcher, she primarily studies the structure and growth of freshwater fish populations. She has contributed to environmental conservation projects and co-authored a study on the growth of the Skadar chub.

### Ivana Čogurić

Ivana is a journalist, author, and environmental activist. Since 2021, she has been part of the women-led ecological movement, Ekopatriotizam. In 2023, she directed two short documentaries, & "Mislov until 2003" and "Pileta Piletovic". Recognised for her environmental activism, she was named Eco Volunteer and later Eco Ambassador of Montenegro by the Environmental Protection Agency, honouring her efforts in community-led protests and removing illegal landfills.

### Jasenka Lalović

Jasenka was born in Bar in 1965 and is a writer known for her trilogy "Hills of sage". The novels explore the role of women in Montenegrin society in the early 20th century, highlighting the significance of those who have been forgotten. Her next novel, "Bastadur", is based on the similar concept, but is focused on men of Montenegro. She is married, has four children, and lives in Belgrade.

### Jelena Jovičić-Petrović

Jelena is a professor of environmental microbiology at the Faculty of Agriculture, University of Belgrade. She is also an initiator and active member of the local citizens' initiative Waterkeepers of Mionica (Ne damo vode Mionice) and a member of the coordination committee of The Network of Academic Solidarity and Engagement.

### Jelena Marojević Galić

Jelena holds a degree from the Faculty of Mathematics and Natural Sciences with a specialisation in Biology and has over 15 years of experience in the civil sector. In 2007, she joined the NGO Green Home, where she was involved in several environmental protection campaigns, including the one against the construction of dams on the Morača River.

### Jelena Popović

Jelena is co-director of the Montenegrin Ecologists Society and one of the key founders of the Save Komarnica initiative. As a biologist and junior dendrochronologist, she is deeply involved in biodiversity research and conservation. She studies local flora and habitats in the Montenegrin mountains and canyons and a significant part of her work focuses on translating nature's complexities into educational and artistic expressions.

### Jovana Popović

Jovana is a Social Media Manager at MES with a background in English language and literature (Spec.) and Painting (BA), currently pursuing an MA in Intermedia at the University of Montenegro. Skilled in content creation, graphic design, video editing, and fluent in multiple languages.

### Jovana Đukanović

Jovana is the founder and CEO of Extraterrestre, a PR, marketing, and events agency. She has an MA in European Studies and is President of the Rotaract Club Podgorica. Jovana has taught at La Sapienza University and the University of Montenegro, and is a selected lecturer in the upcoming "Ready for EU" program, by the Government of Montenegro.

### **Kelsey Aho**

Kelsey is the Watershed Program Manager for Europe & Eurasia with the U.S. Forest Service. In southeast Europe, she maps floods and dams, supports environmental education and scientific research, and fundraises. Outside of work, she collects local river clays which we can hold and explore how the different rivers look and feel.

### Kirsi Hyvaerinen

Kirsi has worked with NGOs, governments, and international development agencies in tourism and destination management since the mid-1990s. She founded her own consultancy in 2013, focusing on capacity building, sustainable tourism, and destination branding. ### **Leonard Sonten**

Leo is freshwater project manager at EuroNatur, focusing on the "Blue Heart of Europe" initiative. He spent the last 15 years working abroad in the fields of aquaponics and marine science. Now, he is dedicating his expertise to coordinating efforts for a sustainable future for the rivers of the Balkans.

Małgorzata is an environmental and energy lawyer who collaborates with NGOs to protect river ecosystems, decarbonise the energy sector, and improve air quality.
